*Terms and conditions of authorisation **

1. The authorisation shall comply with the provisions of the Environment (Protection) Act, 1986 and the rules made there under.
2. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the prescribed authority.
3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the biomedical wastes without obtaining prior permission of the prescribed authority.
4. Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person authorised shall constitute a breach of his authorisation.
5. It is the duty of the authorised person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
6. Please submit the drawing deign of waste water treatment plant within 01 month of issue of this authorization and it should be completed within 03 months.

TERMS & CONDITION OF AUTHORIZATION

- 1 The authorization shall comply with the provisions of the Environment (Protection) Act-1986 and the rules made there under regarding management of B.M.W. In case any of the conditions of the rules has been complied with an institute shall put up an action plan in affidavit within one month of the time bound schedule of the implementation of an action plan with immediate effect.
- 2 An authorization or its renewal shall be produced for inspection at the request of an effect authorization by the prescribed authority.
- 3 The person authorized shall not rent, lend, sell transfer, or otherwise transport the Bio-Medical-Waste without obtaining prior permission of the prescribed authority.
- 4 Any unauthorized change in personnel, equipment or working condition as mentioned in the application by the person authorized shall constitute a breach of his authorization.
- 5 It is duty of the authorized person to take prior permission of the prescribed authority to close done the facility.
- 6 The amount of license and renewal fee for the authorization is payable along with from:- I, at the time of renewal. The renewal application or shall be field before 90 days of expiry of this authorization period.
- 7 An applicant institution shall ensure installation of various arrangements for proper Bio-Medical Waste management with immediate effect as specified below:
 - (A) Category wise segregation of Bio-Medical Waste as specified in **Schedule-I** of the rule.
 - (b) Provision of color coded bins (for storage of BMW) as specified in **Schedule-II**.
 - (c) Provision of Waste sharp destruction treatment/disposal arrangements.
 - (d) Safe transportation arrangement of waste from various wards to treatment site.
 - (e) Installation of treatment and disposal system of BMW as specified in **Schedule -I of BMW (M&H) Rules- 1998**
- 8 B.M.W. Generating units which includes a Hospital, Nursing Home, Clinic, Dispensary, Veterinary Institutions, Animal House, Pathological Laboratory, Blood Bank and related research institutes etc. should take all steps to ensure that such waste is handled without any adverse effect to human health and the environment. In case the institution is disposing off the Bio- Medical Waste through a common. Facility it will be responsibility of the institution to ensure its disposal as Provision of B.M.W. Rules.
- 9 Every occupier. Where required, shall set up in accordance with the time schedule in Schedule-VI, and requisite B.M.W. treatment facility like incinerator, autoclave, microwave system for the treatment of waste or ensure requisite treatment of waste at a common waste treatment facility or any such other waste treatment facility established by other occupier who is having valid authorization from the Board.
- 10 B.M.W. shall be treated and disposed of in accordance with **Schedule-I and** with the standards prescribed in **Schedule -V**. For disposing of categorized BMW through deep burial and/or secured landfill prior approval of the board shall be obtained at such piece of land.
- 11 B.M.W. shall not be mixed with other waste B.M.W. shall be segregated into containers/bags at the point of generation in accordance with **Schedule- II** prior to its storage, transportation, treatment and disposal. The containers shall be labeled according to **Schedule-III**
- 12 If a container is transported from the premises where B.M.W. is generated to any waste treatment facility outside the premises the container shall. Apart from the label prescribed in **Schedule-III** also carry information prescribed in **Schedule-IV**. Transpiration of B.M.W. shall also follow the rules made under Motor Vehicle Act. 1988.
- 13 No untreated B.M.W. shall be kept stored beyond a period of 48 hours. Provided that, if for any reason it become necessary to store the waste beyond such period an authorized person must take permission of prescribed authority and measure to ensure that the waste does not adversely affect human health and environment.
- 14 It shall be responsibility of the occupier generating Bio-Medical Waste/operator of a Bio-Medical Waste treatment facility to arrange for suitable disposal site individually or in association, so as to comply with provisions of these rules.
- 15 Every occupier shall submit waste analysis report to the prescribed authority twice in a year.
- 16 Every occupier /operator shall submit an annual report to the prescribed authority in Form-II by 31Th January ever year.
- 17 When any accident occurs at any institution or any other Bio- Medical waste is handled or during transportation of such waste an authorized person shall report the accident in **Form-III** to prescribed authority forth with.
- 18 Every authorized person shall maintain record to the generation, collection, reception, storage, transpiration, treatment, disposal and/or any form of handling of B.M.W. in accordance with these rules. All record shall be subject to inspection and verification by the prescribed authority at any time.
- 19 The prescribed authority may after giving reasonable opportunity of hearing refuse to grant authorization and reserve all the rights to amend/ cancel /revoke the condition of this authorization in part or whole as and when deemed necessary
- 20 The prescribed authority may cancel or suspend an authorization at any point of time, if for reasons, to occupier/ operator has failed to comply with any provision of the act or rule therein.
